Copyright License Agreement

Copyright requesting party: One For Israel

By submitting the Why I'm One for Israel form and submitting my testimony and media for use by One for Israel Ministries, I agree to the following.

Since the Association films and records testimonies of people and/or interviewees and uploads the recorded videos and/or audios and/or pictures and/or footage and/or movies to different websites and/or social networks and/or newspaper articles and distributes them in many different ways and methods chosen by the Association (here: "Project");

and since the filmed/interviewed party declares that everything said in the interview and on footage are original things and stories that he/she experienced personally and were not taken from or belong to somebody else;

and since the filmed/interviewed party declares that he/she agrees to bestow his/her interview to the Association and to be recorded on video and audio by the team working on behalf of the Association and to give to the Association exclusively and without compensation full copyright and right of intellectual property for unlimited time for the distribution and/or publication and/or lending and/or selling of the film project with or without compensation in every context and way, including a private and/or business related and/or public and/or social and any other type of frame and use chosen by the Association, both in Israel and abroad;

and since the Association agrees to perform the project with the filmed/interviewed party and to receive without compensation the full copyright and the full right of intellectual property for unlimited time in order to make full use of it according to the Association's decisions and in every way and means that might be chosen by the Association;

and since both parties wish to determine in this agreement the conditions for a copyright license according to the below stated agreement;

As I checked the box agreeing to the terms and conditions, I declare and agree on the following conditions:

- A. The introduction to this agreement is an integral part and will be read together with it.
- B. The filmed/interviewed party agrees and declares as follows:
 - 1. To give up my copyrights and intellectual property in favor of the Association without compensation and for unlimited time, and to declare that I never gave and/or granted and/or passed on and/or committed to provide and or pass on and or sell in the future to any kind of cause and/or authority and/or legal body and/or person and/or any other third party one of the rights that are bestowed to the Association mentioned in this agreement.
 - 2. To partake in the project and filming in every location and way chosen by the Association.
 - 3. That the recorded interview that I bestowed on the Association does not represent any violation of the law.

- 4. That the recorded parts are fully and solely under my responsibility and that I alone am responsible for any outcome that may result from the publication of its contents.
- 5. That I hereby grant to the Association and anyone acting on its behalf a license free of charge, not limited in time and not given to a third party to use the footage and the interview in any way and form and that I bestow hereby the Association with the right to give a one year license for the usage of these rights—as a whole or in parts to any other party without the need of receiving my consent.
- 6. The Association shall be entitled to distribute and/or print and/or sell and/or issue by an audio recording and/or video recording and/or through any other means of media the filming and interview project, in its own discretion and choice.
- 7. I hereby release the Association, its employees, cameramen, media team, representatives, officers, directors, members of committee, managers, the president of the association, its CEO and/or every other legal body tied to the Association from any financial claim or legal responsibility and/or any compensation and/or demand and/or claim and/or suit of any kind, that stems from the filming and interviewing and the showing of the videos of any kind, and that I hereby abstain from any claim and/or demand and/or suit that stems from the filming project shot by the Association's team or a team affiliated to the Association.
- 8. To bestow the Association with all copyrights for the use of my pictures, footage, audio recordings and my name for any purpose and for unlimited time through any means of communication chosen by the Association and without limitation, to make any usage and editing of the recordings and/or add and/or change and/or cut them and edit them in any way chosen by the Association, to publish them by printing, on TV, radio, internet, cinema, audio recordings, websites of all kinds and any social network chosen by the Association.
- 9. I release the Association from any claim and/or demand and/or suit including but not limited to libel suits, defamation, invasion of privacy or any other claim that is based on the usage of all the contents mentioned above or any lawsuit on personal or business related damage as a result of my partaking in this film and interview project.
- 10. I am aware that I will not receive any financial recompense and/or any rights and/or benefit from the Association and that all the interviews and footage are given without financial or other recompense.
- 11. I bestow the Association with my agreement out of my own free will without having been pressured.
- 12. I hereby declare that I am over 18 years old, of sound mind and in full right of using my own name and thereby confirm this agreement.
- 13. I declare that my agreement is of my own free will after reading and having the possibility to consult with any authorized agent.
- 14. Any oral or written commitment and/or agreement given on behalf of one of the parties prior to confirming this commitment are null and void.
- 15. The addresses of the Parties are assets forth in the Preamble to this Agreement.
- 16. Any message sent from one side to the other according to the mentioned address shall be deemed to have reached its destination at the end of 72 hours from the time it is delivered to the Post Office by registered mail, within 24 hours of its dispatch by e-mail and/or facsimile, or delivered by hand—at the time of its delivery.
